Social and Economic Impacts of Ocean Acidification

Mr Rashid Sumaila, Director of the Fisheries Centre, University of British Columbia, Canada

Rashid Sumaila is a professor of environmental and fisheries economics at the University of British Columbia and director of the Fisheries Centre and the Fisheries Economics Research Unit in Vancouver, Canada. He is deeply interested in how economics, integrated with ecology and other disciplines, can be used to ensure that environmental resources are sustainably managed for the benefit of all generations. Rashid Sumaila has been recognized for merit with a variety of awards, including, the Leopold Leadership Fellowship, the Pew Fellowship for Marine Conservation, and the Peter Wall Institute Scholar Award. He has given talks at meetings of the United Nations, the White House, the U.S. Congress, the Canadian Parliament, the U.K. House of Lords, and the World Trade Organizations. Rashid's work has been cited by the Economist, the Boston Globe, the International Herald Tribune, the Financial Times, CBC News, and others.

Ms Carol Turley, OBE Plymouth Marine Laboratory, Prospect Place, Plymouth, UK

Carol Turley's research has been centred on the ocean's biogeochemical cycles. She was a member of The Royal Society Working Group on ocean acidification and was a Lead Author on the 2007 IPCC 4th Assessment Report on Climate Change and is a Review Editor for the 5th Assessment Report. Carol is a member of the Executive Board of two EU funded projects on ocean acidification and is the Knowledge Exchange Coordinator for the UK Ocean Acidification Research Programme. She has published on a wide range of topics within the field of ocean acidification, and has presented this information internationally.

Mr Bill Dewey, Public Policy and Communications Director, Taylor Shellfish Company, USA

Bill Dewey has worked for 30 years as a shellfish farmer in Washington State. He owns and operates his own Manila clam farm in Samish Bay. He is also the manager of public policy and communications for Taylor Shellfish Company, the largest producer of farmed shellfish in the USA. Bill Dewey has taken an active role throughout his career on environmental and human health regulations as they affect the shellfish farming community. Mr Dewey serves on a number of boards and committees including the Board of Directors of the National Aquaculture Association, the Pacific Shellfish Institute, and Washington State's Ocean Acidification Blue Ribbon Panel. In 2008, Bill received NOAA's Environmental Hero award in recognition for his dedication to public policy that protects water quality, marine resources and supports sustainable aquaculture.
